Dear Community Leader:

The Rural Alaska Community Action Program, Inc. (RurAL CAP) is pleased to announce the opening of 25 AmeriCorps Member positions in rural Alaska, beginning service in September, 2019. We have fifteen (15) 11-month positions and ten (10) nine-month positions available. Organizations may select which length of service they prefer to best fit their needs/schedule. For example, schools may elect for a 9 month term service length to coincide with the school year or 11 month term to extend programming through the summer.

### AmeriCorps Program Information:

AmeriCorps engages more than 80,000 Americans each year in service to their nation and community at nonprofits, schools, public agencies, and other community and faith-based groups across the country. AmeriCorps members respond to local needs and make a difference by improving lives and local conditions through hands-on service and capacity-building activities. The AmeriCorps program brings benefits to the community and to the AmeriCorps member by providing training, a monthly living allowance of \$1,550 and an education award of \$6,095 upon successful completion of the service year. RurAL CAP and their supporting partners have been providing opportunities for rural communities through AmeriCorps programs for 25 years.

Using Project Venture as the primary intervention, the AmeriCorps Resilient Alaskan Youth program aims to address the high rates of youth substance abuse and suicide in rural Alaska through positive youth development and experiential learning. Project Venture, an evidence-based model recognized by the Substance Abuse and Mental Health Services Administration and the National Registry of Evidence-based Programs and Practices, will be implemented in 25 communities across rural Alaska. Project Venture uses outdoor activities and American Indian traditional values to help youth develop positive self-concepts, effective social skills, a community service ethic, resiliency, and increased decision-making and problem-solving skills. Comprised of classroom-based problem solving activities, adventure-based experiential learning, service learning, and culturally based leadership, Project Venture actively engages youth in

developing life skills while reinforcing traditional Native values such as family, service learning, and appreciation for the natural world.

Utilizing a Strength-based approach, Project Venture is built upon the concept that the indirect, positive approach of experiential learning is one of the most powerful and culturally appropriate means of education and development for American Indian youth. Project Venture has demonstrated success in reduction of risky behaviors, substance abuse, teen pregnancy, violence, depression, and anxiety; and increase in positive youth development indicators including those related to competency, connection, character, caring, confidence, and contribution.

AmeriCorps Members are recruited locally from their communities by a sponsoring **host organization** such as a tribal or city council, local school, community school, local health clinic, or regional or other local entity. Successful applicants are supervised by a locally-identified Site Supervisor and expected to work closely with community residents. This resource is available through grants from the Corporation for National and Community Service, Community Services Block Grant and the State of Alaska, Tobacco Prevention and Control make AmeriCorps placements available at no cost to your organization.

**AmeriCorps Host Organization – How to Apply:**

1. **Recruit AmeriCorps Member Candidates** – Use the enclosed posters and program information to recruit AmeriCorps applicants in your community. Communities must have at least one AmeriCorps applicant to be considered for selection– and are encouraged to have more than one applicant, if possible. Each candidate must complete a member application. People with disabilities are encouraged to apply.
2. **Complete Host Organization Application** – As part of the application, host organizations are required to:
  - Designate a Site Supervisor for the AmeriCorps member, who is a staff member within the host organization, and who will fill out the the host site application. *See “AmeriCorps Site Supervisor Roles & Responsibilities.”*
  - Develop a Service Description/workplan for the RESILIENT ALASKA YOUTH AmeriCorps member based upon community needs and the initiatives.
  - Identify and provide office space and access to a computer, fax and phone. *See sheet on host organization requirements.*
3. **Resolution or Letters of Support**--The host organization should show support for the program by submitting resolutions or letters of support from tribal or city councils, schools, Behavioral Health Aides and other partners such as regional health providers or community agencies. *Request a sample, if needed.*
4. **Submit Host Organization and AmeriCorps Member Applications by Deadlines Below** – These applications should include a resolution or letter of support (host organization), or resume (member).

The host organization will submit both the Host Organization application and AmeriCorps Member Application, which must be postmarked by July 1, 2019 for priority consideration. Feel free to submit a host application while recruiting members before July 1st, but be sure to submit both the host application and member application by the deadline. **RurAL CAP aims to fill all positions with applications turned in on/before July 1<sup>st</sup>.** Apply now!

Applications will be accepted July 1 to August 2 to fill any remaining positions. However, there is no guarantee additional placements will be available.

**Host Organization and Member Selection Process**

1. **Application review** - RurAL CAP staff will review and score host site and member applications in July.
2. **Telephone interview** – Interviews conducted in July and August will include both the Site Supervisor applicant and the AmeriCorps applicant. Candidates are expected to be well prepared with ideas and plans for the year of service with details about creating a longstanding youth program. *The **interview questions** will be sent out before the actual interview to help you prepare.* Ask for it if you did not receive it.

The interview will be conducted by a team of two staff members at RurAL CAP. Successful applicants will be notified in August, and new members will begin their year of service in **September 2019**.
